

Minutes

The Oklahoma State Board of Podiatric Medical Examiners met on May 10, 2024. The special meeting was held consistent with the Open Meeting Act, 25 O.S.2011, § 301 *et. seq.* Advance notice of this meeting was transmitted to the Oklahoma Secretary of State on March 25, 2024, and posted on the Board's website on April 29, 2024, at 11:43 a.m. in compliance with 25 O.S. § 311.9.

Having noted a quorum, Dr. Nelson called the meeting to order at 4:00 p.m.

Following review, Dr. Schuff moved to approve the meeting minutes of March 23, 2024, as written. Dr. Cupp seconded the motion and the vote was unanimous in the affirmative.

Mr. Coker joined the meeting.

The Board then reviewed the request of **ALEXANDRIA KLOECK, DPM**, for an extension of Medical Education requirements. She currently has 30 in-state hours but has not yet registered to obtain the remaining 10 online hours. Dr. Kloeck stated she hopes to get those 10 hours completed by June 30th of this year. Following review and discussion, Dr. Nelson moved that Dr. Kloeck be required to obtain, before the end of this cycle, 10 hours of online CME, 6 hours of CME for BLS which can also be completed online, for a total of 16 CME hours, and be granted a grace period of 12 months to make up the missing CME hours for this compliance period. Dr. Beasley seconded the motion and the vote was unanimous in the affirmative.

BRYAN ANDREW BLANCK, DPM, appeared personally in response to allegations of unprofessional conduct. Joseph L. Ashbaker, Assistant Attorney General, appeared on behalf of State, and Brian J. Kuester, counsel for Defendant, did not appear. All witnesses expected to testify were sworn. All board members answered negatively regarding any reason why they should not be allowed to sit in consideration of this matter. Defendant confirmed counsel assisted him

with the preparation of a Consent Order. Mr. Ashbaker gave a brief history of the matter and presented a Consent Order for the Board's consideration.

Dr. Nelson moved to enter into Executive Session. Dr. Beasley seconded the motion and the vote was unanimous in the affirmative.

Dr. Nelson moved to return to Open Session. Dr. Beasley seconded the motion and the vote was unanimous in the affirmative.

Upon returning to Open Session, Dr. Nelson moved to accept the Consent Order as presented. Dr. Beasley seconded the motion and the vote was unanimous in the affirmative.

Sandra Harrison provided a handout on current legislation and advised that, of most importance, SB 1231 extending sunset of Podiatric Medical Examiners to June of 2027 has been approved by Governor Stitt. The Board thanked Ms. Harrison for the information.

Barbara Smith advised the next board meeting is scheduled for September 27th at 4:00 p.m. at the board office. The Board thanked Ms. Smith for the information.

There being no further business, Dr. Nelson moved to adjourn the meeting. The time was 4:40 p.m.
